He had joined by servitude to his father William - also of 26, Shoe Lane - who had joined 24.11.1812 and was a "Dealer".
14	19.5.1974	No	Mrs Sarah (Sally) Eleanor Ide	1st Hon Freedom Presentation to a Lady. Sally was the wife of William Ide - Master in 1921/22 (20.7.1911). She died 18.12.1977.
15	2.12.1979	7.7.1983	Dr. Joanna Elizabeth Thomas MB.BS.LRCP.MRCS.	The wife of Robert Lorne Thomas - Master 1996/7 (23.3.1972). She was daughter of W R Ide - Master 1964/5 (19.12.1945) & Granddaughter of W Ide - Master 1921/2 (20.7.1911). She became the 1st Lady Liveryman and 1st Lady Master in 2005/6, the same year as her husband Robert served as Master Actuary. This was the first ever Husband & Wife to serve as Masters at the same time in London. Robert died 25.12.2007 and subsequently she remarried in October 2012 to Vincent Emms - Master 1991/2 (22.6.1966).
