2 Lambe - John	13.12.1664	5.7.1665	Resigned for a Fee.
3 Hobson - Thomas	14.2.1666	29.12.1668	Only sworn on 14.2.1666. Again, resigned for a Fee.
4 Ritherdon - William	29.12.1668	18.3.1669	Acted for Thomas Hobson for 6 months prior to own appointment. Had been the Livery's first Beadle.
5 Benning - Richard	18.3.1669	28.9.1671	Elected for 1 year 18.3.1669. Sworn in 17.6.1669. Rechosen 22.9.1670.
6 Probyn - Phillip	28.9.1671	18.2.1672	Initially appointed for 6 months from 28.9.1671. Reported had died 18.2.1672.
7 Banner - Richard	18.2.1672	6.8.1702	Elected & sworn 18.2.1672. Reported had died 6.8.1702.
8 Green - Edward	6.8.1702	28.9.1721	Elected & sworn 6.8.1702. Reported had died 28.9.1721.
9 Dutch - Cornelius	28.9.1721	23.9.1756	Elected by Ballot 28.9.1721. Reported had died 23.9.1756.
10 Dennison - Reginald	23.9.1756	15.2.1776	Elected & sworn 23.9.1756. Reported had died 15.2.1776.
11 Williams - Walter	15.2.1776	19.6.1783	Assistant to R.Dennison was elected 15.2.1776. Reported had died 19.6.1783.
12 Highmore - Anthony (Freeman 21.6.1792)	4.7.1783	18.12.1823	Elected & sworn 4.7.1783.(Attorney at Law). Resignation accepted with regret after 40 years. (Master 1812/13)
13 Clift - James (Freeman 18.6.1829)	18.12.1823	18.6.1857	Elected & sworn 18.12.1823.(Attorney at Law).. Reported had died 18.6.1857.
14 Dineley - Frederick	24.9.1857	30.6.1864	Elected & sworn 24.9.1857.(Solicitor. 6,Austin Friars). Resigned by letter 23.6.1864.
15 Evans - Captain Robert Harding (Freeman 18.12.1867)	22.9.1864	2.11.1911	Elected & sworn 22.9.1864.(36, Newgate St.) Resigned after 47 years due to age - Died 1914. Office became 58,Gracechurch Street.
16 Leckie - George John (Freeman 20.1.1922)	19.12.1912	21.3.1941	Appointed after one year acting as Deputy. Lived at 23, Meredyth Road. Barnes. Office 13, Queen Anne's Gate.Westminster 14.10.1937 - Presented with Testimonial and Medal for serving for 25 years. Died 19.1.1941. Death reported 21.3.1941.
17 Clark - Harry Kenneth Sutton BA. FCA. (Freeman 16.12.1932)	27.6.1941	14.12.1976	Elected Clerk 21.3.1941. Retired 14.12.1976. (Master 1949/50) President Fellowship of Clerks 1956.
18 Willoughby - Philip John JP. FCA. (Freeman 25.3.1971)	14.12.1976	14.12.1989	Appointed after four years as Assistant. Also served as Renter Warden, Prime Warden and Master between 6.12.1984 to 16.12.1987. Retired 14.12.1989. Chief Commoner 1996.
19 Rawles - Brian John BSc. (Freeman 19.3.1985)	14.12.1989	11.12.2003	Appointed after a year as Assistant. Retired 11.12.2003. (Master 2004/5)
20 Smith - Colonel Audrey J. BA. FCIPD. (Freeman 22.6.1999)	11.12.2003	14.3.2011	Appointed after a year as Assistant. Retired 14.3.2011.
21 Robinson - Dr. Trevor John MA.PhD.DIC. FIMC.CMC.MIPD. (Freeman 27.6.2002)	14.3.2011	25.6.2011	Elected and sworn 14.3.2011. Resigned as unwell 25.6.2011.
22 Dellow - Clive William (Freeman 24.3.2009)	22.9.2011	31.5.2012	Elected 16.6.2011. Sworn 22.9.2011 Resigned 14.6.2012 effective 31.5.2012
23 Emms - Vincent Edward (Freeman 22.6.1966)	14.6.2012	24.9.2015	(Master 1991/92)
24 Gillett - Mrs Caroline	24.9.2015	25.10.2016	Designate 13.7.2015. Sworn 8.12.15. Resigned 25.7.2016.
